You usually need a customs form to ship overseas, even with APO, FPO, and DPO mail. The form you need depends on the USPS® mail service you're using and the total value of what you're sending. 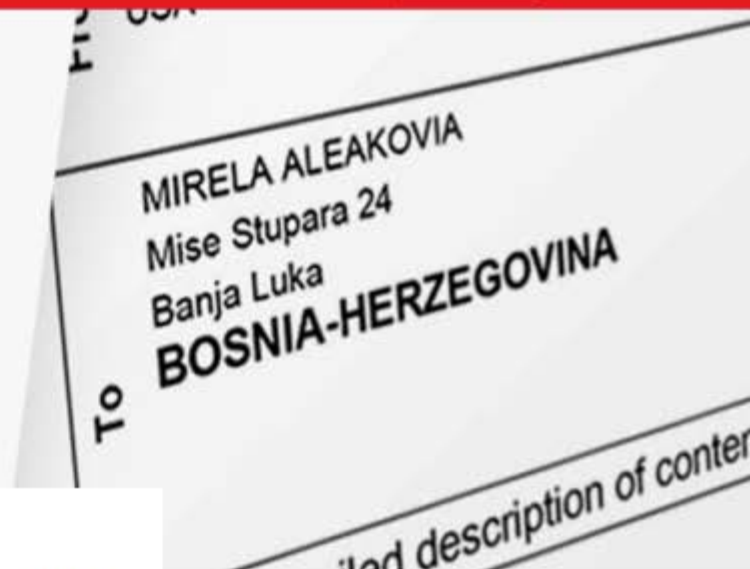

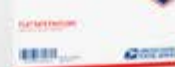
